Norfolk County Sheriff's Office Opens New Civil Process Location in Quincy

QUINCY, MA – Norfolk County Sheriff Patrick McDermott cut the ribbon on a new location for the Sheriff's Office's Civil Process Office in Quincy on Friday. The new office, located at 1255 Hancock Street in Quincy Center, will continue to serve the civil process needs of Norfolk County but in a more centrally located and accessible site.

"Our Civil Process office plays an important role in helping residents serve process and other critical legal services, which can be confusing to the average person," said Sheriff McDermott. "I am grateful to the strong working relationship our office has with the City of Quincy and the Chamber of Commerce, which has made this move possible. These relationships are key to ensuring that public safety is accessible to both individuals and businesses alike."

At the ceremony, Sheriff McDermott was joined by business leaders and elected officials, including Quincy Mayor Thomas Koch and Tim Cahill of the Quincy Chamber of Commerce. Cahill thanked the Sheriff for his support of local businesses and welcomed the Civil Process office to its new headquarters.

Mayor Koch praised the move in remarks he delivered at the ceremony. "It's good for the public, it's good for the County, it's certainly good for the Sheriff, and it's good for the square," he said. "We've had a lot of changes to the square, but we still have some challenges from time to time. I think the presence of this office here will also be a benefit."

The NCSO's Civil Process office is available to serve a number of legal and civil actions across Norfolk County, including serving civil process, conducting asset forfeiture, enforcing capias warrants, and conducting evictions. The office also conducts asset searches free of charge for attorneys and plaintiffs who do business with it in Norfolk County.
